New Massachusetts State Regulations Require Data Security Plans That Go Beyond HIPAA

Whether or not you are a "Covered Entity" under HIPAA, you are required to comply with the state's new regulation "Standards for The Protection of Personal Information" regarding data security of personal information, and the regulation's requirement of a *Written Information Security Program* (WISP). Both the Federal HIPAA and the Massachusetts regulation affect the way chiropractic offices manage information in the course of business operations. Where HIPAA policies protect patient information, the state regulation goes beyond HIPAA by encompassing financial information and your employees' information.

This seminar provides chiropractic offices with the core requirements of both HIPAA and WISP, an overview of the regulations, and important ready-to-use information. This is an especially important seminar for new doctors and staff members who have not had HIPAA training. The seminar also is important for doctors needing to comply with the state's WISP standards, and is valuable to those who want to review their current HIPAA policies, train new staff members, or meet the HIPAA three-year retraining requirements.
