A Brief History of Chiropractic in Massachusetts

**1912**: First chiropractic office opens.

**1915**: Chiropractic is declared practice of medicine. Chiropractors are jailed over next 40 years for practicing medicine without a license.

**1955:** Last chiropractor jailed for failing to register as a physician.

**1955-1964:** All attempts at licensure fail. Massachusetts Chiropractic Association (MCA) is founded.

**1964:** President Malcolm Macdonald unifies 39 MCA doctors to fight for licensure.

**1966:** Governor John A. Volpe signs Chiropractic Enabling Act.

**1968**: Massachusetts Chiropractic Society, Inc. replaces MCA.

**1972**: Medicare reimbursement for chiropractic services begins.

**1984**: After years of political work, MCS spearheads passage of Insurance Equality Law.

**1988:** Legislature requires BCBS coverage for chiropractic services.

**2006:** Legislature requires chiropractic coverage in MassHealth.

2012: \$40 GIC cap is lifted.

**2012:** Chiropractic included in new Cost Containment Law that will radically alter healthcare in Mass.
